SUPPLY OF SPORTS LOTTERY TERMINALS TO SHANXI PROVINCE

The Board is pleased to announce that Lottnal, a subsidiary of the Company, has won a bid to supply Sports Lottery terminals to Shanxi Province. In 2014, the Group has expanded its Sports Lottery terminal business to cover 9 provinces and regions across China, including Gansu, Guizhou, Zhejiang, Anhui, Guangxi Autonomous Region, Heilongjiang, Inner Mongolia Autonomous Region, Qinghai and Shanxi.

The Board of Directors (the "Board") of China LotSynergy Holdings Limited (the "Company", together with its subsidiaries, the "Group") is pleased to announce that Guangzhou Lottnal Terminal Company Limited (廣州洛圖終端技術有限公司, "Lottnal"), a subsidiary of the Company, has won a bid to supply Sports Lottery terminals to Shanxi Province. Lottnal will soon sign the relevant supply contract with Shanxi Sports Lottery Administration Centre.

In recent years, Shanxi Province has achieved yearly Sports Lottery sales growth through the construction of management, sales and promotion channels. In 2013, Sports Lottery sales in Shanxi Province grew by 54% year-on-year, ranking sixth in the nation by sales growth, while sales from January to October 2014 have already exceeded that of full year 2013.
