## **FURTHER WON SPORTS LOTTERY TERMINAL PROCUREMENT PROGRAMME FROM HENAN**

The Board is pleased to announce that Lottnal, a subsidiary of the Company, has recently won a bid for Henan Sports Lottery Administration Centre's "2016 Sports Lottery CTG Terminal Procurement Programme". This is the second time in which Lottnal has won a single batch bid with sales volume over a thousand terminals from the province of Henan.
