The Board is pleased to announce that Huacai Yingtong has entered into the Cooperation Agreement with Lenovo Mobile whereby the parties will collaborate to offer mobile lottery services to Lenovo Mobile's mobile phone users.

#### **Cooperation Agreement**

The Board of Directors (the "Board") of China LotSynergy Holdings Limited (the "Company") is pleased to announce that, Beijing Huacai Yingtong Technology Company Limited (北京華彩贏通科技有限公司) ("Huacai Yingtong"), a wholly-owned subsidiary of the Company, entered into a Cooperation Agreement (the "Cooperation Agreement") with Lenovo Mobile Communication Technology Limited\* (聯想移動通信科技有限公司) ("Lenovo Mobile") in April 2010.
