### **AUTHORIZED BY HUNAN PROVINCIAL SPORTS LOTTERY CENTRE TO ENGAGE IN SALES OF SPORT LOTTERIES VIA TELEPHONE**

The Board is pleased to announce that a wholly-owned subsidiary of the Group has been successfully authorized by Hunan Provincial Sports Lottery Centre as a sales agent to engage in the sales of Sport lotteries via telephone.

This announcement is made pursuant to Rule 17.10 of the GEM Listing Rules.

The Board of Directors (the “Board”) of China LotSynergy Holdings Limited (the “Company”) is pleased to announce that, Beijing Huacai Yingtong Technology Company Limited (北京華彩贏通科技有限公司) (“Huacai Yingtong”), a wholly-owned subsidiary of the Group, entered into a cooperation agreement (the “Cooperation Agreement”) with the Sports Lottery Administration Centre of Hunan Provincial Sports Bureau (“Hunan Provincial Sports Lottery Centre”) on 6 May 2010. Under the Cooperation Agreement, Huacai Yingtong has been authorized by Hunan Provincial Sports Lottery Centre as a sales agent to sell Sport Lottery computer-generated tickets in Hunan Province via telephone (mobile phone and fixed line phone). Huacai Yingtong will receive a sales commission calculated as a certain percentage of the total sales revenue so generated. The term of cooperation shall be three years.

Hunan Provincial Sports Lottery Centre is the sole issuance and administration body for Sport Lottery in Hunan Province, China. In 2009, sales of Sport lotteries in Hunan Province amounted to nearly RMB1.2 billion, representing an increase of approximately 35% over 2008.

This announcement is made pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”). The Cooperation Agreement does not constitute a notifiable transaction of the Company pursuant to Chapter 19 or 20 of the GEM Listing Rules.
