ANNOUNCEMENT

The Company would like to further clarify that one independent third party as mentioned in the Announcement (the “Independent Third Party”) is currently holding 48,459,360 shares of the Company, representing approximately 4.85% of the issued share capital of the Company, and has entered into a placing agreement to subscribe for 100,000,000 shares of the Company, one Independent Third Party has entered into a placing agreement with the Company to subscribe for 100,000,000 shares of the Company and the other Independent Third Parties do not currently hold any securities in the Company. None of the Independent Third Parties are currently acting or presumed to be acting in concert with any other shareholders of the Company.

Save for the above, the Board confirms that there are no negotiations or agreements relating to intended acquisitions or realisations which are discloseable under Chapters 19 and 20 of the Rules Governing the Listing of Securities on The Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”), neither is the Board aware of any matter discloseable under the general obligation imposed by Rule 17.10 of the GEM Listing Rules, which is or may be of a price-sensitive nature.
