## FURTHER WIN IN THE SUPPLY OF SPORTS LOTTERY TERMINALS TO ZHEJIANG PROVINCE

The Board is pleased to announce that Lottnal has won a bid to supply Sports Lottery terminals to Zhejiang Sports Lottery Administration Centre. This is the second win for Lottnal in the terminal procurement of the province.
